The type of personal information we collect

In order to give professional holistic therapy treatments, I will need to ask for and keep information about your health. I will only use this for informing treatments and any advice I give as a result of your treatment.

The information to be held is:

Your contact details

Medical history and other health-related information

Treatment details and related notes

How we get the personal information and why we hold it

Most of the personal information we process is provided to us directly by you for one of the following reasons:

For informing treatments and any advice I give as a result of your treatment.

For the safe and correct usage of essential oils in custom blended aromatherapy products

We use the information that you have given us in order to:

Provide you with the best possible treatment options, support and advice.

Ensure when making a custom blended product we can provide the most benefits of aromatherapy.

We may share this information with Information Commissioners Office or any lawful organisations

Lawful Basis for holding and using Client Information

Under the UK General Data Protection Regulation (UK GDPR), the lawful basis we rely on for processing this information are:

(a) Your consent. You are able to remove your consent at any time. You can do this by contacting Healing Hands/Ceri Bruinsma, 17 Vallance Road, Liverpool, L4 2UP

(b) We have a contractual obligation

(c) We have a legal obligation:

1.1. 'Claims occurring' insurance: (records to be kept for 7 years after last treatment)

1.2. Law regarding children's records (records to be kept until the child is 25 or if 17 when treated, then 26)

1.3. CNHC requirements to retain information for 8 years

1.4 (d) We have a vital interest

(e) We need it to perform a public task

The personal information we hold will include; Name/initials, Date of birth, Email Addresses, Contact details ie phone numbers/Addresses and GP details We may contact your GP if we feel we need to obtain their advice or recommendation on any contraindications on treatment and will only do this with your consent

(f) We have a legitimate interest [i.e.my requirement to retain the

information in order to provide you with the best possible treatment options and advice]

As I hold special category data (i.e. health related information), the additional condition under which I hold and use this information is: for me to fulfil my role as a health care practitioner bound under the AoR Confidentiality as defined in the AoR Code of Practice and Ethics.

How we store your personal information

Protecting your Personal Data

I am committed to ensuring that your personal data is secure. In order to prevent unauthorised access or disclosure, I have put in place appropriate technical, physical and managerial procedures to safeguard and secure the information we collect from you.

I will contact you using the contact preferences you have given me.

We keep Consultation forms and or index cards for 7 years We will then dispose your information by deleting digital records and or shredding paper records

Your data protection rights

Under data protection law, you have rights including:

Your right of access - You have the right to ask us for copies of your personal information.

Your right to rectification - You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.

Your right to erasure - You have the right to ask us to erase your personal

information in certain circumstances.

Your right to restriction of processing - You have the right to ask us to restrict the processing of your personal information in certain circumstances.

Your right to object to processing - You have the the right to object to the processing of your personal information in certain circumstances.

Your right to data portability - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.

THERAPIST'S RIGHTS

Please note:

If you don't agree to your therapist keeping records of information about you and your treatments, or if you don't allow them to use the information in the way they need to for treatments, the therapist may not be able to treat you

Your therapist has to keep your records of treatment for a certain period as described above, which may mean that even if you ask them to erase any details about you, they might have to keep these details until after that period has passed

Your therapist can move their records between their computers and IT systems, as long as your details are protected from being seen by others without your permission.
